Mr. MORELLE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 447) to amend the Act of August 16, 1937 (commonly referred to as the “National Apprenticeship Act”) and expand the national apprenticeship system to include apprenticeships, youth apprenticeships, and pre-apprenticeship registered under such Act, to promote the furtherance of labor standards necessary to safeguard the welfare of appren-

tices, and for other purposes; providing for consideration of the concurrent resolution (H. Con. Res. 11) establishing the congressional budget for the United States Government for fiscal year 2021 and setting forth the appropriate budgetary levels for fiscal years 2022 through 2030; and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 447) to amend the Act of August 16, 1937 (commonly
4 referred to as the “National Apprenticeship Act”) and ex-
5 pand the national apprenticeship system to include ap-
6 prenticeships, youth apprenticeships, and pre-apprentice-
7 ship registered under such Act, to promote the furtherance
8 of labor standards necessary to safeguard the welfare of
9 apprentices, and for other purposes. All points of order
10 against consideration of the bill are waived. The amend-
11 ment printed in part A of the report of the Committee
12 on Rules accompanying this resolution shall be considered
13 as adopted. The bill, as amended, shall be considered as
14 read. All points of order against provisions in the bill, as
15 amended, are waived. The previous question shall be con-
16 sidered as ordered on the bill, as amended, and on any
17 further amendment thereto, to final passage without inter-
18 vening motion except: (1) one hour of debate equally di-
19 vided and controlled by the chair and ranking minority
20 member of the Committee on Education and Labor; (2)

1 the further amendments described in section 2 of this res-
2 olution; (3) the amendments en bloc described in section
3 3 of this resolution; and (4) one motion to recommit.

4 SEC. 2. After debate pursuant to the first section of
5 this resolution, each further amendment printed in part
6 B of the report of the Committee on Rules not earlier con-
7 sidered as part of amendments en bloc pursuant to section
8 3 of this resolution shall be considered only in the order
9 printed in the report, may be offered only by a Member
10 designated in the report, shall be considered as read, shall
11 be debatable for the time specified in the report equally
12 divided and controlled by the proponent and an opponent,
13 may be withdrawn by the proponent at any time before
14 the question is put thereon, shall not be subject to amend-
15 ment, and shall not be subject to a demand for division
16 of the question.

17 SEC. 3. It shall be in order at any time after debate
18 pursuant to the first section of this resolution for the chair
19 of the Committee on Education and Labor or his designee
20 to offer amendments en bloc consisting of further amend-
21 ments printed in part B of the report of the Committee
22 on Rules accompanying this resolution not earlier disposed
23 of. Amendments en bloc offered pursuant to this section
24 shall be considered as read, shall be debatable for 20 min-
25 utes equally divided and controlled by the chair and rank-

1 ing minority member of the Committee on Education and
2 Labor or their respective designees, shall not be subject
3 to amendment, and shall not be subject to a demand for
4 division of the question.

5 SEC. 4. All points of order against the further amend-
6 ments printed in part B of the report of the Committee
7 on Rules or amendments en bloc described in section 3
8 of this resolution are waived.

9 SEC. 5. Upon adoption of this resolution it shall be
10 in order to consider in the House the concurrent resolution
11 (H. Con. Res. 11) establishing the congressional budget
12 for the United States Government for fiscal year 2021 and
13 setting forth the appropriate budgetary levels for fiscal
14 years 2022 through 2030. All points of order against con-
15 sideration of the concurrent resolution are waived. The
16 amendment printed in part C of the report of the Com-
17 mittee on Rules accompanying this resolution shall be con-
18 sidered as adopted. The concurrent resolution, as amend-
19 ed, shall be considered as read. All points of order against
20 provisions in the concurrent resolution, as amended, are
21 waived. The previous question shall be considered as or-
22 dered on the concurrent resolution, as amended, and on
23 any further amendment thereto, to adoption without inter-
24 vening motion or demand for division of the question ex-
25 cept three hours of debate, with two hours equally divided

1 and controlled by the chair and ranking minority member
2 of the Committee on the Budget and one hour, on the
3 subject of economic goals and policies, equally divided and
4 controlled by Representative Beyer of Virginia and Rep-
5 resentative Schweikert of Arizona or their respective des-
6 ignees.

7 SEC. 6. Rule XXVIII shall not apply with respect to
8 the adoption by the House of a concurrent resolution on
9 the budget for fiscal year 2021.

10 SEC. 7. House Resolution 73 is hereby adopted.

11 SEC. 8. (a) Clause 3(g)(3)(C) of rule II is amended
12 to read as follows:

13 “(C) Upon receipt of an appeal pursuant to subdivi-
14 sion (B), the Committee on Ethics shall have a period of
15 30 calendar days or five legislative days, whichever is
16 later, to consider the appeal. The fine will be upheld unless
17 the appeal is agreed to by a majority of the Committee.
18 Upon a determination regarding the appeal or if no appeal
19 has been filed at the expiration of the period specified in
20 subdivision (B), the chair of the Committee on Ethics shall
21 promptly notify the Member, Delegate, or the Resident
22 Commissioner, the Speaker, the Sergeant-at-Arms, and
23 the Chief Administrative Officer, and shall make such no-
24 tification publicly available. The Speaker shall promptly
25 lay such notification before the House.”.

1 (b) Section 4(a)(2) of House Resolution 38 is amend-
2 ed to read as follows:

3 “(2) a fine imposed pursuant to this section shall be
4 treated as though imposed under clause 3(g) of rule II,
5 and shall be administered as though pursuant to clause
6 4(d) of rule II, except that if a Member, Delegate, or Resi-
7 dent Commissioner files an appeal under clause
8 3(g)(3)(B) of rule II prior to the date on which the Com-
9 mittee on Ethics has adopted written rules, the period for
10 the Committee’s consideration of the appeal under clause
11 3(g)(3)(C) of rule II shall begin on the date on which the
12 chair of the Committee notifies the Member, Delegate, or
13 Resident Commissioner that the Committee has adopted
14 such rules.”.

15 SEC. 9. Section 5 of House Resolution 8, agreed to
16 January 4, 2021 (as amended by House Resolution 41,
17 agreed to January 13, 2021), is amended by striking
18 “February 11” each place that it appears and inserting
19 “March 12”.
